5th January 1929

Extract from The Fife News: **New Year** – "Wintry weather prevailed at the advent of New Year. The event was heralded quietly in the town, although several of the younger generation went first-footing."

Extract from The Fife News: **British Legion** – A branch of the British Legion has been formed in Falkland. The various Committees, with Mr R. Wallace as secretary, were appointed at a meeting held in the Institute last week, and arrangements are going on apace, a 'smoker' having been arranged to be held on the first Friday in February. Local ex-Service men should derive benefit from the movement."

12th January 1929

Extract from *The Fife News*: **Pulpit** – "Revs. J.K. Russell, Parish Church, and J.P. Batchelor, U.F. Church, exchanged pulpits on Sunday morning."

Extract from The Fife News: **Presentation** – "Mr George Finlay, who has been a troop leader in the local Boy Scouts for some time, and who is leaving soon for New Zealand, was met by the members of the 22nd Fife Troop at the Scout headquarters in Falkland, and presented with a pocket book, as a parting gift and token of esteem. Scout Wm. White made the presentation and Troop-Leader Finlay suitably replied."

Extract from The Fife News: **Appeal** – "In response to an appeal made in the Parish Church on behalf of the Miners' Fund, the congregation subscribed a sum of over $\pounds 15$."

Extract from The Fife News: **Concert** – "Under the auspices of the Parish Church Woman's Guild, a splendid concert was held in the Drill Hall on Friday evening. The Rev. J.K. Russell occupied the chair in the presence of a large and appreciative audience. The artists, who were a distinguished company, included Miss Lumsden, Eden Valley House, Freuchie, and Mr Geo. Watt, Collessie (violinists); Mr D. Leven, Auchtermuchty (trombone); Miss Bonthrone, Newton House (elocutionist); Miss Taylor, Auchtermuchty; Miss Dunn, Collessie, and the Rev. W.G. Mitchell, Freuchie (soloists), and Miss Wilson and Mrs Scott Davidson (variety). Mrs Arnott, Weddersbie, Collessie, presided at the piano."

Extract from The Fife News: **Sequel to Motoring Accident** – "The trial took place in Cupar Sheriff Court on Tuesday of Robert Daniel Crawford, farm assistant, c/o Dykes, Westfield, Falkland, who was charged with having, on 16th November, in Muir Street, Thornton, driven a motor car in a negligent manner on the wrong side of the road, and caused it to run against and knock down and injure Lizzie Paterson, schoolgirl, 18 Brown Crescent, Thornton, and Jean Taylor, schoolgirl, South End, Thornton. Accused was defended by Mr R.N. Robertson, solicitor, Cupar.

Giving evidence, Jean Taylor said she and her companion were walking along the east side of Main Street, Thornton. Witness was on the pavement and her companion was walking in the gutter as near to the pavement as possible. She heard nothing, but a car must have come up behind them, and she heard her companion call out, 'Oh, Jean!' She must have fallen on her head – that was all she knew until she came to herself in Dr Tait's surgery. She had been confined to bed for about a week. Lizzie Paterson gave corroborative evidence. P.C. Archibald McLean, of Thornton, said he found blood-marks about two feet from the grass verging the footpath.

Accused's statement was that he was driving about the centre of the road at about 12 m.p.h. The light from the street-lamp struck the windscreen of his car and was reflected back in his eyes and he was temporarily blinded. He immediately braked the car. Owing to his momentarily being dazzled, he must have struck the girls, who, as far as he could see, came out suddenly in front of him.

Sheriff Dudley Stuart said there had been negligence. If anyone was dazzled by a lamp he had no business to go on, and if anything happened, he would be held responsible. He imposed a fine of 40s."

26th January 1929

Article in The Fife News: Football – Millwood v Lomond Thistle

"Played at Woodside on Saturday afternoon. Half-time reflections of this match made one pause and ask oneself how many more goals the home team would add during the second half, because at the interval they were leading by 5 goals to 1. On the turn-about, however, Falkland asserted themselves and made a very spirited reply, and rattled on goals in rapid succession, completely changing the aspect of the game. The homesters only got one point in this period, and when the final whistle blew, they were leading by the odd goal in eleven. The match was under Markinch and District Welfare Combination auspices."

Extract from The Fife News: **B.O.A.F.G.** – "The annual general meeting of the Lomond Oak Lodge (No. 387) was held in the Town Hall on Thursday evening last week, W.M. Bro. Robt. Kennedy presiding over a good attendance. In his remarks, the W.M. commented on the splendid financial position of the Lodge. During the year there was an increase in funds of £216, thus bringing the total funds to £2,474. Sickness benefit paid out amounted to £87. Eight new members were admitted to the Order, making the total membership 173. The balance-sheet and auditors' report were unanimously adopted, and Bro. T. Drysdale, auditor, made some explanatory remarks. Bro. J.S. Hardie, the retiring secretary, also spoke. The following officebearers have been appointed for 1929:-

Rev. J.P. Batchelor for Alexandria

"At a meeting of Alexandria North U.F. Church congregation, Dumbartonshire, held on Monday night, the Rev. J.P. Batchelor, Falkland, was unanimously elected as minister of that church in room of the Rev. Kenneth MacLennan, who has been translated to Prestonpans U.F. Church. *Mr* Batchelor was inducted to Falkland U.F. Church on 30th August 1917, having been called from Maud, Aberdeenshire, in succession to the Rev. J.H. Morrison, who was translated to Newhills, Aberdeen. Mr Batchelor, who is the second son of Mr A. Batchelor, Dundee, graduated M.A., and took his divinity course at Aberdeen. During his last year there, he conducted a mission station at Maud. He is convener of the Foreign Missions Committee of Cupar U.F. Presbytery, and as such is a strong and earnest pleader for that cause. He is a popular pastor in his congregation, and a forceful preacher."

2nd February 1929

Article in The Fife News: Football – Lomond Thistle v Dunshelt United

"Played at Falkland on Saturday afternoon under Markinch and District Welfare Combination auspices. This match was of more than a passing interest, as was made evident by the large number of spectators present. No doubt the fixture being of the 'local derby' nature, created a tense atmosphere, while at the same time the teams are running neck and neck in the Combination. Falkland were first to settle down, and after about fifteen minutes, Thomson opened their account. The visitors replied strongly, but Meldrum gave them the right-about. Midfield play followed for a spell until the home left wing got possession. Birrell carried well up before centring, and with the Dunshelt defence completely at sea, Bett was left with nothing to do but tap the ball home. After these reverses, Dunshelt put more spirit into their play. Young, the centre forward, broke through, and his shot carried past the post, with Ritchie coming out to meet him. The referee appeared to err badly at this point, in granting a corner kick, as the ball went clearly past from Young's foot. This corner kick eventually gave the visitors their opening goal, as during the scrimmage in the goalmouth, Dalrymple scored. Half-time arrived with Falkland leading by 2 goals to 1.

The Thistle started off again in promising fashion, and the United's defence were early called upon to clear. Considering the slippery and ice-bound surface of the ground, the game was fought out on fast and clean lines. Dunshelt put on pressure and Dalrymple brought his side on level terms. Nettled at this sudden spurt on the part of their opponents, the Thistle swept down on the United's citadel, and Bett again put his side in the lead. From this point onwards the homesters dominated the situation, and it came as no surprise when Bett added a fourth goal for Falkland, and incidentally secured his own 'hat-trick', truly a good performance for an outside right."

At the former function, Bailie Robertson, manager of the Linen Factory, occupied the chair in the presence of a large company. After tea had been partaken of, the audience were treated to a splendid concert by a party of artists from Strathmiglo. The programme rendered was as follows:-

The Clerk to Ladybank District S.M.C. wrote stating that his Committee had agreed to take no action in regard to the proposed inter-school sports. The Falkland Committee, though taking no action meantime, are therefore free to proceed on their own initiative.

Arrangements were made for ascertaining the repairs which might be carried out on schools during the summer vacation.

The attendance returns showed the prevalence of an extraordinary amount of sickness among pupils. For the month, Strathmiglo had the highest average with 87.6%, and Falkland the lowest with 68.8%.

A letter was read from Rev. J.P. Batchelor, Falkland, resigning his membership, on the occasion of his removal to Dumbartonshire, and, this having been accepted, it was remitted to the Clerk to thank Mr Batchelor for his past services, and also to take the necessary steps in connection with filling the vacancy."

"Everyone regretted the absence of Mrs Batchelor through illness, but at the same time were very glad to see the Manse family present. Mr Batchelor was presented with a wallet of Treasury notes at the hands of Mrs Baird, and Mr Walter Peggie, who officiated at this ceremony, said he been called upon to perform a pleasant, but, at the same time, perhaps, a sad duty. When they read in the papers some time ago of Mr Batchelor's call, they had to ponder over the loss it would mean to them all.

Mr Batchelor had been over eleven years with them, and the roots of his ministry had become firmly embedded in the congregational soil. During all that time, Mr Peggie said, he could not remember a Deacons' Court or Kirk Session meeting at which they had had to recourse to voting, so harmonious were the proceedings. Mr Batchelor had endeared himself to all the congregation, especially to the aged and infirm. In calling on Mrs Baird to hand over the gift, Mr Peggie asked Mr Batchelor to accept it as a tangible token of the respect and esteem in which he was held.

Mr Batchelor, in making reply, thanked one and all for their great kindness to him. In the first place, he was leaving Falkland with mixed feelings, as that had been his first charge, and it was to Falkland he brought his bride. They had become very much attached to Falkland folks, and they felt as if tearing themselves away. He could

always look on his family as Fifers, born and bred. Nothing gave a minister greater pleasure than to see his congregation making regular attendance at church, and he asked them earnestly to be present at least once every Sunday. He was going to a larger congregation, and hoped the prayers of the Falkland folks would follow him in his calling.

The Rev. J.K. Russell, Falkland Parish Church, remarked on the privilege he had been given in being admitted to the intimacy of the gathering. Mr Batchelor and himself had been on the most friendly terms ever since their becoming acquainted, and he wished to thank Mr Batchelor very sincerely for his splendid work in conducting all the services and ministerial labours during the Great War when he (Mr Russell) was away. Mr Batchelor had responded nobly to all that was asked of him, and he hoped that Mrs Batchelor would be restored to health and strength again, and that they would be able, along with their family, to enjoy their new charge.

During the evening, songs were rendered by Miss Penman and Messrs A. Archibald and T. Drysdale, and violin selections were given by Mr Marshall Stark. Miss C. Peggie presided at the organ. It being his last Sunday as a minister in Falkland, Mr Batchelor occupied the Parish Church pulpit in the morning, while Mr Russell conducted the service in the U.F. Church."

With the exception of Wright and Mason, the Stewart's batsmen lacked confidence, and were all disposed of for 35 runs.

The Falkland team's opening was very shaky, and only 14 runs had been scored when the third wicket fell. It was left to Schofield and St Clair – an old Stewart's boy – to make the runs, and right well did they do so. Both hit out vigorously, and put on over 20 runs before being separated. Schofield is a greatly improved batsman compared with a few seasons ago. He now believes in attacking the bowling, and scores freely all round the wicket. Baxter had a merry innings, and it was refreshing to see him open his shoulders.

"At Doo Cot Park, Perth, on Saturday afternoon. Had the weather been dry previously, there is no doubt the wicket at this palatial cricket ground would have been a batsman's paradise. After a night's rain, the ground was holding a bit, and the batsmen had to force the ball away over the close-cropped grass. The home lot batted first. P. Lawson and J. Lawson opened the bowling for Falkland, and the latter's first five overs were maidens. The damp wicket caused the batsmen to go cautiously. Their period at the crease lasted over an hour-and-a-half, and they could have added several more runs had they 'had a go.' Smart, Simpson, McNab, and Normand got double figures in the side's total of 71.

Falkland's opening was decidedly shaky. Schofield and T. Drysdale were the only players to make anything of a show up to the halfway stage. When the fifth wicket fell the score-sheet registered only 34 runs, and it was feared a rot had set in. This fear was soon dispelled by the confident manner in which John Lawson and Stewart Drysdale set about the bowling. This pair of colts defied change after change, and 25 runs had been added when the latter left to a catch at the wicket. When Birrell – the last man – came in, there was an air of tension all round, as Falkland only required five runs for victory. Birrell realised his responsibility, however, and along with Lawson, pulled the game out of the fire. What at one time seemed a hopeless position was turned into a sterling victory, thus again demonstrating a fact which has been proved on several occasions, that every member of the Falkland team can handle a bat.

He was an ideal guide in every way, and visitors were much impressed by his historical knowledge and the way in which he imparted the information at his command. Mr Bruce was in attendance when Queen Mary visited the Palace in 1924, and had the honour of a conversation with Her Majesty. He is survived by a widow and daughter. The remains were laid to rest in Falkland Cemetery on Sunday afternoon, when the Rev. J.K. Russell, minister of the Parish Church, conducted the service at the graveside. Among the vast throng of mourners was a company of local ex-Servicemen, under Major A. Macdonald, to pay their last respects to a staunch comrade, and their wreath of Flanders poppies expressed silent esteem, along with the many other floral tributes from relatives and friends."

At Falkland

"On Tuesday evening, Commander Cochrane spoke at Falkland, Freuchie, and Kingskettle, and met with a good reception at each place, his addresses being attentively listened to.

The chair at Falkland was taken by Hon. Sheriff Stark, Cupar, in the unavoidable absence of Mr David Bonthrone, Newton of Falkland, and Provost Hopkins. There was an attendance of about 50, including a large number of women.

Commander Cochrane, in the course of his address, said that a week ago five leaders of the Liberal party appeared on posters, but it appeared they now needed seven leaders, because two more heads appeared on the posters. How many heads they would have by the time the election came, heaven only knew.

Referring to the General Strike, he said nobody wished to go back to the conditions which prevailed in industry up to 1926. The change had come about through a change of feeling in the country, which the Government had backed. Mr Stanley Baldwin had realised the common-sense of the people; he never got rattled in the days of the General Strike. It had been said that he (the Commander) was opposed to Trade Unions. He had always supported Trade Unions, where necessary, in the interests of their members industrially. It was a different thing whether they should interfere with politics. In connection with the safeguarding of industries, he said he had never heard any rigid free trader admit that it made any difference whether they imported into this country manufactured goods or raw materials. It made all the difference in the world. If they could import raw materials, and manufacture the things here for their own people and for export, it was much better than importing goods and not making any attempt to manufacture them for themselves. (Applause).

No questions were asked."

Article in The Fife News: Former Falkland Minister as Author

"We observe that the Rev. J.H. Morrison, M.A., who was minister of the United Free Church of Scotland at Falkland for nearly 20 years, is gaining further distinction in the world of literature. His first successful effort, which gave him no little fame in clerical and missionary circles, was the production of 'On the Trail of the Pioneers'. An outstanding feature in Mr Morrison's production of this well-known book, readable by anyone whether or not in favour of Foreign Missions, is that he had not visited any of the fields of mission work so accurately described before writing. It was not long after the publication when the author, who had become suddenly famous, was appointed as a delegate to Livingstonia. The expedition referred to was in course of progress at the time of the outbreak of the Great War in 1914, and the traveller had

to return to port by a circuitous route to avoid a threatened attack by the enemy's vessels at sea.

Illustrated accounts were published of the tour in the U.F. Church 'Record' shortly after his return. Since then numerous well-known books have been published by Mr Morrison, including 'Streams in the Desert', 'Missionary Heroes', and also contributions to series of publications, such as 'The Church's Work Abroad', one of the volumes classed as 'The Layman's Library'. The latest reference in a well-known paper to the author relates to a publication of a somewhat different type. As the volume does not appear to have reached many in this locality, we repeat the paragraph which appeared in our last week's issue:-

'The New Physics and Religious Thought', by the Rev. J.H. Morrison, M.A., is an exceptionally interesting and instructive review of

"modern scientific thought and speculation."

Mr Morrison came to Falkland about the time of the Union of the Free and U.P. Churches, and the prolonged unfortunate litigation which followed caused no little stir in the Churches all over Scotland. He left Falkland in 1917 for Newhills, near Aberdeen, where he is a popular and successful preacher and pastor."

22nd June 1929

Article in The Falkland News: Cricket – Falkland v Markinch

"At Scroggie Park, Falkland, on Saturday afternoon. While the home team have had a successful season so far, their most decisive victory was registered on Saturday, and Markinch had the misfortune to be the opposition. The home team's batting was more consistent than of late, and the 'tail wagged merrily'. Batting first on a splendid wicket, Chalmers and Law, for Markinch each opened with singles. Both seemed to be gradually settling down, when the latter was bowled. Gamba and Mair were easily disposed of, but J. Morrison, along with Chalmers, offered some resistance, and this couple took the score to 37 for the fourth wicket. After Morrison's departure, a rot set in, and, try as he might, Chalmers could not find anyone to stay with him. He was eventually taken in the slips after a splendid and patient innings. Certain members of the visitors' side were rather careless in their manner of running between the wickets, three of them being run out.

The Falkland team opened confidently, and Drysdale collected a couple of fours off Morrison. Bad luck again dogged Schofield, and he had the misfortune to step in front of a straight one. Peter Lawson was too anxious to hit, and paid the penalty, but Hopkins batted well, and along with Birrell sustained a good partnership. It was left to the latter batsman and Anderson to win the game, and they did so in no uncertain manner. Attacking the bowling from the outset, they scored with freedom all round the wicket, and the century mark was passed in a short time, thus giving Falkland their first total of over a hundred for the season. "A small debt action of considerable interest was called in Cupar Sheriff Court on Thursday last week. The action was at the instance of James Douglas, potato merchant, Falkland, who sued John Small, farmer, The Mount, Cupar, for £7 9s 11d, representing damage for alleged breach of contract in respect of a sale by defender to pursuer of five tons of Golden Wonder ware potatoes, delivered on or about 12th February last, which, he said, were frozen and unmarketable. Proof was fixed for 11th July. The claim was made up as follows:-

Railway charges on waggon from Cupar to Glasgow, £3 14s 11d; carriage to Cupar, 12s 6d; 100 sacks lost at 41/2, £1 17s 6d; loss of profit, £1 5s.

Liability for the sum sued was denied in respect that defender fully implemented his obligations under the contract. The potatoes were not frosted when handed over to the Railway Company. Defender held that his obligations terminated when he handed the potatoes over to the Railway Company, and he was not liable for the frosting occasioned while the potatoes were in transit if they were found to be frosted, which was not known and not admitted. In any event, he held the sum sued for was excessive.

Pursuer, he said, previously stated has claim for loss at £3 14s 11d, which he ultimately modified to £2 10s. Defender counter claims for £20.

Action over Frosted Potatoes

"An action of much interest to farmers was heard in Cupar Sheriff Court on Thursday. John Douglas, potato merchant, Falkland, sued John Small, farmer, The Mount, Cupar, for £7 9s 11d damages for breach of contract in connection with the sale of 5 tons of Golden Wonder potatoes to the pursuer by the defender. The case for the pursuer was that the potatoes were frozen before they were put on rail, and the defence was that the potatoes were put on rail in good condition. The defender counter-claimed for the price of the potatoes,, restricted to £20.

Mr J.L. Anderson, writer, Cupar, appeared for the pursuer, and Mr I.W. McInnes, W.S., Cupar, was for defender.

A report upon the weather conditions upon the dates when the potatoes were loaded and put on rail, which had been prepared by the Meteorological Office at Leuchars, was submitted, and accepted by both agents."

Pursuer's Evidence

"Giving evidence, pursuer said he had been in business as a potato merchant for 12 years. On 22nd January 1929, he bought from the defender a waggon of 5 tons of potatoes at £5 15s per ton. The conditions of the contract were that defender had to load the potatoes at Cupar Station, and he (witness) was not entitled to accept the potatoes if they were frosted. In his view it was a condition of these contracts that the potatoes should be loaded in fresh weather, so that they might not be frozen. The potatoes were re-sold to Paul & Weir, potato merchants, Glasgow, at a price of £6 per ton. Paul & Weir sent the bags to Cupar for the potatoes. Two days after they were frosted, and they must refuse them, and a letter followed the next day, stating that in the opinion of Paul & Weir the potatoes had been refused, and defender that the potatoes had been refused, and defender that the potatoes had been refused, and defender told him to try to make the best of them. That was the common practice in the potato trade.

Defender ultimately went to see the potatoes, and again advised witness to make the most of them. Witness was informed by Paul & Weir that the potatoes were useless, and had had to be carted to a dump in Glasgow. They sent him an account for £6 4s 11d for the rail carriage and the price of 100 bags. Until the counter-claim was lodged, defender never made any claim upon witness for the price of the potatoes. Witness offered to let him off with 50s per ton, but defender would not entertain it.

The week commencing 11th February was one of exceptional frost. It was not prudent for anyone to load perishable potatoes in such weather, and a farmer loading potatoes during such weather must take the risk. Defender had ample time to load the potatoes during fresh weather.

In cross-examination, pursuer said Mr Small's contract ended when he delivered the potatoes at Cupar Station, provided they were in good condition. He could not believe that the seed, passed through the riddle along with the ware, would not be frosted as well as the ware. If the seed had not been frosted, it might be possible that the ware were frosted through being exposed in a railway truck for two days, and in transit in Glasgow.

In answer to his agent, pursuer said it took a little time for the frost to manifest itself, and if he had examined the potatoes before they left Cupar Station, they might not have shown signs of frost."

Not Sufficiently Strawed

"James D. Irvine, 16 Haldane Street, Scotstoun, Glasgow, manager of Paul & Weir, Glasgow, said when the waggon of potatoes arrived on Wednesday, 13th February, it was put into a covered shed, and was examined the following morning. Article in The Fife News: Cricket – Falkland v Dunnikier – 'Lost Ball'

"Played at Scroggie Park, Falkland. The Royal burgh team sustained their second successive defeat on Saturday. Their batting has not been consistent of late, due, probably, to the loss of practice through the intervention of holidays. Batting first, Dunnikier started disastrously, four wickets being down for three runs. Bain, the former Kirkcaldy crack, gradually brought the game round, and was ably backed up by Aitken and Bryan, the latter having 13 not out.

The home batsmen were too eager to hit, and consequently paid the penalty for impatience. P. Lawson and Baxter were the only members of the side to reach double figures. An incident of note during the Falkland innings was a 'lost ball'. A hit by Baxter landed in the long grass near the boundary, and there being no fielder in the vicinity at the time, some difficulty was experienced recovering the ball, with the result that one of the fieldsmen called 'Lost ball'. This is an unusual incident in cricket circles, and the ruling is that in addition to the runs made by the batsmen prior to the call of 'Lost ball', six runs are added.

Bowling for Falkland, P. Lawson captured six wickets for 17 runs, and J. Lawson four for 20. For Dunnikier, Bain took four for 23, Currie three for 2, Croall two for 10, and Campbell one for 7. Scores:-

"The monthly meeting of Falkland District School Management Committee was held in Falkland School on Monday evening – Rev. G. Scanlan, Strathmiglo, chairman, presiding.

The Falkland side, with the exception of their captain, put up a sorry batting display. Peter Lawson was the only player to show any confidence, and he demonstrated that the bowling could be hit by sending three deliveries from Duncan clean out of the grounds. The remainder of the innings was just a procession, and the total score only reached 32.

Article in the Fife News: Frosted Potatoes – Decision in Cupar Litigation

"At Cupar on Monday Sheriff Dudley Stuart issued the interlocutor in the small debt action brought by James Douglas, potato merchant, Falkland, against John Small, farmer, The Mount, Cupar. Pursuer sued for £7 9s 11d as damages for breach of contract in respect of the sale by the defender to the pursuer of 5 tons of Golden Wonder potatoes, and defender counter-claimed for the price of the potatoes, restricted to £20.

Pursuer's case was that the potatoes were frozen before being put on rail at Cupar, and defender contended that the potatoes were in good condition when loaded in the waggon at Cupar Station.

Sheriff Dudley Stuart assoilzies the defender, and grants decree for his counterclaim of £20 with expenses.

In his note the Sheriff states:- The evidence in this case relates to a consignment of Golden Wonder ware potatoes, sold and dispatched by the defender from Cupar to Glasgow, and, on inspection by the consignee, found to be seriously frosted and, it is said, unmerchantable. The case arises in the form of an action of damages by the purchaser for breach of contract, his contention being that the frosted condition of the potatoes is attributable to the defender's negligence. This the defender denies, averring that he duly implemented the contract, and he counter-claims for the contract price.

The main topic of controversy in evidence is the state of the weather which prevailed during the period between the removal of the potatoes from the pit on defender's farm and their examination in the consignees' shed in Glasgow. This period extended from the morning of Monday, 11th February, until the morning of Thursday, 14th, and it is proved that between these dates, very severe frost occurred. The pursuer's case is that on the Monday, when the potatoes were taken from the pits, the weather was so severe as to be quite unsuitable for exposing them: that the same conditions prevailed on Tuesday morning, when the potatoes were carted to Cupar Station, and tucked for conveyance to Glasgow. Upon this assumption the pursuer maintains that the potatoes were frosted before delivery at the station, as the result of the defender's negligence in executing the contract, and that this conclusion is supported by the fact that the frost was found to have affected the bags in the interior of the consignment. It was said, I think, that on the assumption that the frost took effect after dispatch from Cupar and during transit by rail, the defender was not justified in dispatching the potatoes during the exceptional state of the weather, and thus putting the risk of damage upon the pursuer."

Defender's Case

"The defender's reply is that the weather conditions on the Monday and Tuesday were quite suitable for handling and discharging potatoes, that while in his possession, they were well protected from risk of frost, and that the damage which they suffered must have arisen from exposure after he had implemented his contract by delivery to the Railway Company. It is evident that no direct proof can be got which will show at what stage in their transit the potatoes were frosted. The inference must be drawn from the facts and circumstances and of these the weather conditions during the period in question are the most important. What those conditions were on the 11th and 12th February is a matter of dispute. If the weather was as severe as the pursuer alleges, and such as would expose the potatoes to the risk of damage by frost, the inference may be that the defender was in fault, and must bear the loss arising from this exposure in unsuitable weather. The presumption, in short, would be that the damage was done while the property and the risk were his. The question, therefore, is whether this presumption is supported by the facts.

The sequence of events is this. The potatoes on the defendant's farm were opened on Monday morning, 11th February, and the potatoes were carted to a shed, where they remained in the carts during that night. On Tuesday morning they were conveyed to Cupar Station and handed over to the Railway Company to be delivered to Messrs Paul & Weir in Glasgow. They reached Messrs Paul & Weir's premises on Wednesday afternoon, and the truck containing the potatoes was housed in their shed. On Thursday morning they were examined, and found to be seriously frosted.

I think it is proved that the potatoes were sufficiently protected during the night of Monday and during their conveyance to Cupar Station; that is, that the usual precautions were taken to avoid damage by possible frost. But the pursuer maintains, and seeks to prove, that the weather on Monday and Tuesday was so exceptionally severe that no prudent farmer would have risked opening his pits and dispatching potatoes."

Conflict of Evidence

"I remark, in the first place, that I cannot readily assume that the defender, an experienced farmer, would have incurred this risk if the weather was manifestly unsuitable. Pursuer was not pressing for delivery, and the defender could choose his day. His reply is that the weather on Monday and Tuesday morning was in no respect abnormal and perfectly safe for lifting and carting potatoes. Upon this point there is certainly a conflict of evidence, and it appears that in some places, spoken to by the pursuer's witnesses, severe weather prevailed on Monday, and potato lifting was in consequence suspended. But the conditions in one district, or in one situation, are not necessarily the same as in others. The question is – What were the conditions at The Mount and in the immediate neighbourhood? The defender's evidence, and that of his foreman, is that the weather was guite suitable for the work, and this is confirmed by the testimony of Mr Arbuckle, who depones that on his farm of Luthrie and on the adjacent farm of Colluthie, potato lifting and dressing was done on Monday. It is true that both of these farms are situated at a lower level than The Mount, but they lie not far from it, and, in my opinion, afford a more reliable indication of the weather in the immediate vicinity than evidence regarding the conditions which prevailed elsewhere. I note, also, the evidence of Mr Morgan, who, on Monday, was

dressing potatoes at Gateside in weather which he describes as suitable for the purpose. Gateside is very near The Mount, and the fact emphasises that conditions may vary as between one district and another."

Weather on the Journey

"The conclusion I have reached appears to receive support from the meteorological report furnished by the Aerodrome Officer at Leuchars. This shows that on Monday night only 3 degrees of frost were registered. The severe frost did not occur until Tuesday night, when the record was 13 degrees, and on Wednesday the lowest point during the winter, 19 degrees was recorded. These facts appear to me to suggest as the more probable conclusion that the damage to the potatoes was either during their transit by rail, or possibly – though this seems least likely – after their arrival in Glasgow. As the waggon containing them did not reach Messrs Paul & Weir until Wednesday afternoon, it was presumably exposed to the weather during Tuesday night, and Tuesday night was exceptionally severe. I don't omit to notice the opinion of several of the pursuer's witnesses to the effect that the damage must have been caused prior to delivery at the station. This is an inference which, expressed by experts, is entitled to consideration. But, in the view which I take of the evidence regarding the weather conditions – that prior to Tuesday afternoon the weather was not severe, but, as clearly appears, that Tuesday night and Wednesday were the coldest of the winter – I am unable to accept this opinion as conclusive in the matter."

Defender not Responsible

"I do not concern myself with the question whether the onus of proof is upon the pursuer to prove that the defender failed to implement the contract, or upon the defender to prove that he did implement it. I have considered the evidence in order to reach the more probable conclusion from the facts disclosed. What that conclusion is I have already indicated, and it is in favour of the defender. I shall, therefore, assoilzie the defender, and grant decree for the amount of his counterclaim, namely, £20, with expenses. I should add that I do not think it is proved that the defender acquiesced in the rejection of the potatoes by the purchaser. I accept his statement that he maintained, when informed of the damage, that he was not responsible.

17th August 1929

Article in The Fife News: Cricket – Falkland v Springfield

"This match proved very interesting and resulted in a victory for the visitors by nine runs. Both teams were under strength and the honours of run-getting fell to the earlier batsmen. Springfield batted first and mustered the respectable total of 93, to which Stewart, Garland, Arthur and Dowie were the chief contributors. Steadiness was their motto, and though at times inclined to be slow, they did not hesitate to have a 'go' at any loose ball.

Falkland opened briskly and 67 was on the telegraph at the fall of the fifth wicket. At this rate of scoring the surpassing of the opposing total seemed a matter of time, but alas, the homesters developed a 'tail', and the last four batsmen had only one run between them to their credit. John Lawson played a sterling defensive game, but was unable to get anyone to stay with him.

A circular was read from the Authority instructing the Committee to inform janitors that on no account were pupils to be allowed to assist with work, the explanation of this being that in several instances the Authority had become liable for compensation on account of mishaps."

"The monthly meeting of Falkland Town Council was held in the Town Hall on Wednesday evening – Bailie G. Robertson presiding in the absence of Provost Hopkins.

Bailie Grant suggested the provision of suitable lighting at the public lavatories, and it was left in his hands to procure details of various schemes.

The Chairman intimated that the Ministry of Transport had now agreed to pay 25 per cent of the cost of upkeep of unclassified roads within the burgh, in addition to the same on roads in Classes I and II. He also stated that, along with representatives from other small burghs, he had met the Secretary of State for Scotland to protest against inadequate representation on County Councils under the new Act. The full conditions, as published, however, showed that burghs were to be much more fully represented, and on the new Fife Council, Falkland would have one representative.

The annual abstract of accounts, duly certified by the auditor, was submitted, and after full consideration was adopted and signed. All the accounts are in a good condition. The common good showed assets amounting to £1752 10s, including a cash balance of £363, the reduction of £123 on last year being more than accounted for by the erection of the lavatories at a cost of £183. Attention was drawn to the increasing amount of arrears of rates (now £45 10s), and also the sum of £40 13s 2d spent on repairs at the housing scheme, but it was explained that about £20 of this was accounted for by re-painting.

The rates for the coming year were duly confirmed, except that $\frac{1}{2}$ d per £1 had been added to the burgh general rate. This year, owners will pay a total of 4s 2 $\frac{1}{2}$ d per £1, and occupiers, 5s 7 $\frac{1}{2}$ d, a total of 9s 10d per £1, as compared with 10s 6d per £1 last year.

The Town Clerk reported the disposal of the old water cart, for which 30s had been got.

It was agreed to let the Lower Town Hall for juvenile dancing classes, to be conducted by Miss Dodds, Leslie.

A requisition, signed by 12 ratepayers, was submitted, asking the Council to convene a public meeting, to consider as to the construction of a bowling green, and, after full consideration, to meet the Council to arrange preliminary details.

The condition of certain parts of the footpaths in the town was brought under the notice of the meeting, and instructions were given to have these attended to."

Article in The Fife News: Cricket – Falkland Averages

"Although hardly so successful as last year, Falkland have had quite a good season. Twenty matches were played, of which 10 were won, 7 lost, and 3 drawn. Runs scored totalled 1473 for the loss of 192 wickets, an average of 7.67 runs per wicket, against opponents 1415 runs for 167 wickets, average 8.47. Peter Lawson, captain of the Club, leads in both batting and bowling, and has also most catches to his credit. The individual figures are as follows:-

After consideration, the assessor (Mr Hardy) suggested a reduction of £5, and the Magistrates agreed to this. It was stated that a number of workshops in the Burgh would benefit under the De-rating Act."

Article in The Fife News: Football – Millwood (Woodside) v Falkland Thistle

"The above teams met at Woodside on Saturday, and a rather featureless game was the outcome. Midfield play was the order all through, and two fast shots by Chapman, the visitors' centre, were the only incidents of note during the first half. About ten minutes from the end, Falkland were awarded a penalty, but Chapman, to the chagrin of his side, banged the ball against the goal-keeper. The final whistle sounded with no scoring."

28th September 1929

"The above teams met in a friendly match at East Shore Park, Newburgh, on Saturday. The first half opened briskly. Some of the young lads showed nice footwork, and both 'keepers had to be on the alert all the time. The visiting forwards played with fine understanding, and caused the Newburgh defence continual worry. The Falkland lads opened the scoring, and this seemed to awaken the home Scouts. They replied with some good tries but the visiting 'keeper kept a clean sheet for a time. After a nice run, however, Newburgh got on level terms, and the teams crossed over with one goal each to their credit. The second half was equally exciting, both goals being visited in rapid succession. The home team scored again, and from that point had the best of the game. They added a third goal to their total and ran out victors by 3 goals to 1. Scoutmaster F. Gardiner, as referee, handled the game with ability."

Owing to failure to obtain a candidate on these terms, the General Interests Committee agreed to a life charge, with the result that an immediate and unanimous appointment has been made. Rev. Mr Leishman, who has been 14 years in his present charge, has just retired in order to facilitate a union with the other Kelty U.F. Church."

Extract from The Fife News: Falkland Doctor Fined for Negligent Driving

"At Cupar Sheriff Court on Tuesday, a fine of 30s was imposed by Hon. Sheriff Stark upon Dr Patrick Stephen Gerrard Cameron, Canonbury, Falkland, who was charged with having on 30th August, on the public highway at the junction of Main Street with Rumdewan and South Street opposite the old Fire Station, Kingskettle, driven a motor car in a negligent manner on the wrong side of the road, and caused it to collide with and damage a motor omnibus driven by George Todd, motor driver, 20 Bridgeton, Kirkcaldy. In the original complaint accused was charged with driving while under the influence of intoxicating liquor, and the case was down for trial. Mr D.M. Baird, for accused, said he would plead guilty to negligent driving if that part of the charge alleging that accused was under the influence of drink were withdrawn.

Mr P.J. *McPherson, depute-Fiscal, said, after consultation with Mr Baird, he had agreed to alter the charge to one of negligent driving. Mr Baird said that the allegation that accused was under the influence of intoxicating liquor having been withdrawn, he would plead guilty to negligent driving. The accident was a very simple one. The respondent was travelling on Main Street, Kingskettle, and was under the impression that the bus intended to drive straight on. Accordingly, he cut the corner, and the collision took place. No one was hurt, and no material damage was done. Mr P.J. McPherson detailed the damage, and said that the collision was obviously a serious one."*

5th October 1929

Article in The Fife News: Football – Stratheden v Falkland

"There was a strong westerly wind blowing when the Welfare game between Stratheden and Falkland began at Strathmiglo on Saturday, and the visitors, who won the toss, took advantage of the elements. Naturally the bulk of the pressing came from the Falkland side, but thanks to the strong game put up by the home defence and somewhat erratic shooting of the visitors, the score sheet was blank at half-time. The Falkland forwards showed more penetrative force than the home lot, but their finishing gave room for improvement.

Stratheden forced three unproductive corners on resuming, when the wind had eased considerably. The Falkland backs, especially Anderson, whose height was a valuable asset, defended stubbornly. A raid by the visitors' left found Farmer hard pressed, and the extreme winger shot hard past Brown at the foot of the post. This put more life into the game, but there was too much looseness amongst the home inside men, who did not have the best assistance from their halves. Raids and counter raids were the order, till the Falkland custodian, making a faulty clearance, Morrison levelled the scores. This gave the home lot more heart, and shortly after the home outside left added number two, with a shot which struck the far post in its progress into the net. Through a misunderstanding, one of the Falkland defenders picked up the ball, and was accordingly penalised, Clark putting his side's total to three. A. Chapman added number four shortly after, and a game in which the homesters were not three goals better than their opponents ended, Stratheden 4; Falkland 1.

An attempt to place the ball, by the home halves, would immensely help their side and improve their own value, while quicker parting with the ball by the extreme wingers would be equally valuable."

The annual appeal on behalf of the hospitals met with a ready and splendid response on the part of the congregation, and at the service several of the gifts in kind were displayed. 90*lb jam,* 10*lb tea,* 40*lb sugar,* 1 ½ cwts. Mixed vegetables, 1 cwt. Potatoes, 30*lb apples,* 3*lb grapes,* 11*b butter,* 5 chickens, 2 doz. Eggs, varied parcels of groceries, and masses of beautiful flowers. There was also a tiny tea set for children. £10 14s in money was also forwarded, and the Institutions to benefit are Edinburgh, Perth, and Dundee Infirmaries."

Article in The Fife News: Falkland Town Council

"The monthly meeting of Falkland Town Council was held in the Town Hall on Wednesday evening – Provost Hopkins presiding.

The holidays for next year were fixed as follows:-

New Year's Day, spring holiday, 7th April; Victoria Day, 22nd May; autumn holiday, 6th October.

The Clerk reported that the members of the Council who retire this year are Bailie Grant and Councillors T. Drysdale, Henry, and Skinner. The first three were present, but gave no indication of their intentions.

Provost Hopkins expressed the hope that all four would see fit to take up their duties again.

A request was submitted from the Co-operative Women's Guild, requesting more upto-date fittings for their meeting-place in the Lower Town Hall, but it was unanimously agreed that the low rent charged prevented this.

A letter was read from Rev. J.K. Russell, stating that it was proposed to form a Badminton Club among the young ladies connected with his congregation, and requesting the use of the Drill Hall. The Council appreciated the desirability of forming a Club in Falkland, but were unable to let the hall at the terms suggested.

Some comment was caused by the receipt of an account for £17 5s 11d in connection with the Williamstsdt Hospital.

The Clerk explained that, although they had only sent one or two patients, that sum covered a number of years, and the new arrangement for Thornton Hospital now superseded this.

A letter was read from the Board of Health, directing attention to the large number of properties within the burgh without modern sanitary conveniences, and it was agreed to write to the proprietors of these pressing for the introduction of better accommodation. It was also remitted to the Town's Committee to provide a proper lavatory at the Town Hall.

A preliminary meeting between the Council and those interested in the formation of a bowling green was arranged for 16th October.

A license was granted for increased petrol storage at St John's Linoleum Works."

12th October 1929

The date of the induction was fixed as Thursday, 14th November, at three o'clock, Rev. Fred. Simpson, Freuchie, to preach, the Moderator to induct, and the Rev. James Bell, Auchtermuchty, to deliver the addresses.

Rev. J.K. Russell, Falkland, said as Mr Leishman's future nearest neighbour, he offered him his own welcome and the welcome of Falkland Old Church. If Mr Leishman was on the lines of Mr Batchelor and Mr Morrison, he had no doubt that Mr Leishman and himself were in for a very hearty fellowship. (Applause)."

Article in The Fife News: Work of W.R.I.'s - Falkland

"A meeting was held in the Drill Hall, Falkland, on Monday evening, Mrs Morgan, Kilgour, presiding over a company of about fifty ladies. Article in The Fife News: Centralisation in Rural Schools

Rev. G. Scanlan's Comments at Falkland

"That there were grave disadvantages connected with the centralisation of advanced division scholars in rural districts was the opinion advanced by Rev. G. Scanlan, Strathmiglo, chairman of Falkland District School Management Committee, at the Committee's monthly meeting in Falkland School on Monday night.

The matter arose in an informal discussion following a reading of the Education Authority's minute, showing that the complaint regarding obsolete accommodation at Strathmiglo had been referred for consideration, in view of the proposal to concentrate at Auchtermuchty. Mr Scanlan said he knew of rural pupils leaving home at half-past six in the morning, having an inadequate mid-day meal, and not returning home until half-past six at night. He had asked one pupil who travelled to a secondary school if he had formed any school friendships, and the answer was no. The boy had no time.

When rural pupils travelled to a school miles away from home they lost a good deal of their individuality, and became just a cog in the wheel. It might be all right to centralise in some cases, as, for instance, pupils going from Thornton to Kirkcaldy, but in more rural districts, there were serious drawbacks.

Another member of the Committee said he knew young folks who had attended a central secondary school, and who were now pulling turnips. It would almost seem that the time and money spent on their secondary education had been misspent."

Simpson, Freuchie, who delivered an appropriate address. Thereafter the Moderator of the Presbytery, Rev. A.E.G. Gordon, Kingskettle, carried through the induction.*

After the ceremony, Rev. James Bell, Auchtermuchty, addressed the new minister and congregation."

Advice to New Minister

"To Mr Leishman he said: -

'In addressing you to-day with words of counsel on your entering on the pastoral charge of this congregation, it cannot be regarded as presumption on my part, for though you have already behind you many years' experience of the ministry, the Presbytery in its wisdom has deputed me, as a senior minister, to discharge this important and somewhat difficult task. What makes the task easier, however, is that very past experience of yours, for I have only to put you in remembrance of what you already know. At the same time, as the subject of ministerial duty is presented to you by another mind than your own, there may be some things said which will prove profitable to you.'

'I cannot do better in the beginning than by reminding you of the great central object of the Christian ministry, which may be put in briefest form as winning souls to Christ and keeping them. In these days of ours the Christian minister is tempted to range over a wide range of subjects, for the purpose of catching and maintaining the interest of his hearers. When knowledge is so widely disseminated by so large an amount of reading, both of an exciting and of a solidly interesting character, it is demanded of the pulpit to keep abreast of the thought and the interests of the day. and that is a demand that must be recognised. But the central truth of the Gospel must never be lost sight of, nor must it be given only a secondary place in the instructions and in the exhortations of the pulpit. The business of the preacher is to make all subjects subservient to the saving truth in Christ. If there be a subject introduced that cannot be readily and naturally related to the central figure of the Gospel, it has no business to be there, for the ideal of preaching is that of St Paul. You will speedily find, or have already found, that this is no limitation of your range, no hindrance to variety of statement, no abatement of interesting matter in your preaching. But the effectual application of your wide knowledge and reading to the central theme will depend upon your own love and devotion to the Saviour Himself. That love and devotion will transform all your knowledge, giving it a higher denominational value. Without this essential spiritual qualification our best efforts in the pulpit may become as sounding brass or a tinkling cymbal.'

"The advice of the apostle Paul to Timothy to 'give attention to reading' is one which no minister can afford to neglect, and yet which not a few neglect, in the sense of not making their reading of the right kind, and in failing to relate their miscellaneous reading to the great work of the ministry. It is undoubtedly true that there is an amount of light reading which can serve no other purpose than to relieve the strain of work, and the anxiety associated with it; but the man who is faithful with himself will see to it that there is no over-indulgence here. With regard to reading that tends to enlarge the view and widen the interest in the problems of science and of public morality, which may seem at first sight to have little bearing on the work of the ministry, I would say that this is by no means lost labour. Whatever tends to advance his culture must be of service to the minister. But he must have the power of bringing forth from his treasures things new and old and applying them to his central object, the winning and upbuilding of members of the church. The secret of this application of your general knowledge to your work as preacher and pastor is that you should have your work at heart, and be like the wayfarer in Horace 'totus in illis.'

'But there is a special as well as general reading. In whatever calling a man may be, it is essential that he should know most intimately the details of his own business, and that is surely true of the sacred calling of the ministry of the Word. Perhaps on no other calling does a more extensive literature exist. One look, however, is essential round which almost all others are gathered. If in your reading you find yourself lost in the multitude of books about the Bible, your safe course is to return to that for yourself, and to select besides some few out of the many, which will throw most light on the truth contained in it. Yet ever remember that the Spirit of God enlightens the minds of those who in faithful dependence on His help study its pages for themselves'

'I need hardly urge you to have mind upon your bodily health. If, as Sir Wilfred Grenfell said in his Rectorial address last week, 'Our bodily machine is only a farm of energy', 'an altered form of ether, for use just in this particular cosmos', it is our duty to keep it in order for the work we have to do with it, for the sound body has a close relation to the sound mind. Good health is essential not only for the study and for effective preaching, but also for the exercise of the pastoral office. On this latter let me add a few words.'

'The work of the pastor is to some types of character more difficult and exacting than that of the preacher. Yet success in this part of ministerial duty is perhaps more fruitful in the spiritual life of the people than the word from the pulpit. It is indispensable in the work of the minister that he should be well known in the homes of his people. There he comes more closely in contact with them, and there he exerts, whether he knows it or not, a stronger personal influence. The difficulty is to find the right words to speak, the right chords to touch, the right counsel to impart. It is not the place for sermonising, nor is it the place for the utterance of mere platitudes. What is it then, that will make his intercourse with them pleasant for himself and profitable as well as pleasant for them? That is an open secret, well known to us all, but not so easy to put into practice. It is to see your people as brethren in Christ. The heart of the pastor goes out after every member of his flock. He loves them with a true affection, and that love will prompt the word to speak. Sympathy in their joys and sorrows will give grace to the lips in your intercourse with them.'

'Finally, let me remind you that example is equally important with precept, and that your people will look to you for consistency of speech and life, and the more they see of this in your daily walk and conversation, the more they will look to you for instruction and guidance. We commend you to God for all help and strength to perform the duties you are now undertaking, and pray that your labours in this field may be abundantly blessed.'

Address to Congregation

To the congregation Mr Bell said:-

'I have now to address to you a few words as to your duty as a Christian congregation on the occasion of having a new minister set over you in the Lord. You may perhaps think you are sufficiently admonished from Sabbath to Sabbath, but yet this is a special occasion in which the address must differ widely from the ordinary words from the pulpit. You have heard the counsels given to your minister, and I hope to be equally plain with you.' 'I have no doubt that many of you will be ready to say, 'We have been told all these things so often that we know them well; that we are to be regular in our attendance at church, that we are to be attentive hearers and doers of the word, that we are to give freely and conscientiously for the upholding of the ministry at home and in the mission field, that we are to remember that our minister is only a man and at times subject to weakness and mistakes like ourselves, and that we are to bear each other's burdens and to help and encourage our minister in all his work for us. Of course, you are to strive to do all these things. They follow necessarily from the relation in which you stand to him, and to the great King and Head of the Church. I take these things for granted, and I assume that you know them and sometimes think of them. But what I wish to say to you as briefly as possible is to put before you some considerations to enforce these duties.'

'The first is that of personal responsibility. Each of you is a member of this congregation, and, I hope, a living member, for a member slumbering or inert, is not to be counted at all. No member is entitled to say that because others are doing so much, he or she may lean upon them. Each one has to do his part, for the strength of the whole is a combined strength of the individuals. If your place in the pew is vacant when you could be there, if the funds go back because you have not contributed, or if reproach comes on the name of Christian because of your inconsistency or misconduct, the responsibility rests with you. Let me remind you of St Paul's parable of the body and its members. He showed how each member must be alive, taking each his or her own share, humble or important as it may be, in order that the whole may be a living, healthy body.'

'A second consideration to stimulate the fulfilment of duties is that of 'esprit de corps', the sense of your duty and brotherhood as a congregation. You are one body, having a life of your own. You know of how great importance this is in, say, a regiment, a community, a nation. As a body you have an honour to maintain, a spiritual life to cherish, a character to show before your fellow-men. If there is life in the individual members there will be life in the whole body. But you are to feel and act as having also a corporate life. You are to think not only of your personal affairs, but to be helpful and enthusiastic in the life of the congregation. If one member suffers, the rest are more or less affected thereby. The life and prosperity of the whole is the aim of your association.'

'One more consideration I offer you. It is this. We are, as St Paul declares, 'one body in Christ'. Our oneness as a congregation is only part of a larger oneness in the wider Church of Christ. Societies and corporations, communities and nations, are constituted by some common principle to which they adhere. The Christian congregation is formed into a living whole by being united to Christ in faith and life. It is in view of this sacred principle of our common life in Christ that I call upon you to observe and fulfil those duties as a congregation which you know so well; and I leave this thought with you that you may become, whatever your numbers are, a living, vigorous congregation within the Church of Scotland.'

Social Meeting

'In the evening a social meeting of welcome was held, when Rev. W.J. Auld, Freuchie, interim moderator in the vacancy, presided at the outset. The new minister was presented with a wallet of Treasury notes, and Mr Auld received an umbrella for his services. During the evening, addresses were delivered by Rev. R.W. Reid, Dunfermline; Rev. W. Forbes, Cairneyhill; Rev. J.K. Russell, Falkland; Rev. F.A. Simpson, Freuchie; and Rev. J.P. Batchelor, Alexandria, former minister of the church. The augmented choir, under Mr W. Burgon, rendered anthems; solos were given by Miss L.H. Thompson, Strathmiglo, and Mr Alex. Archibald, Falkland; and violin selections by Mr M. Stark, Falkland. The accompanist was Miss C. Peggie, church organist.'

'On Sunday, Rev. R.W. Reid, Dunfermline, will introduce the new minister to his congregation, and Mr Leishman will conduct his first service in the afternoon."

23rd November 1929

Article in The Fife News: Football – Falkland Thistle v De La Rue's (Leslie)

"This match, which was under Markinch and District Combination auspices, attracted a goodly number of spectators at Falkland on Saturday afternoon. The dangerous nature of the pitch, owing to recent frost, was not conducive to good football, with the result that the match was rather a tame affair. The locals played uphill in the first-half and after a period of mid-field play, Munro, the centre forward, sent in a strong shot which was well held by the Leslie 'keeper. Both sets of forwards could make little headway on the hard and slippery ground. About ten minutes from half-time a weak clearance let the visitors through, and Moir opened their account.

After the interval, Falkland attacked in earnest, but found the Leslie defence in good form. Eventually McBain got through and sent in a bouncing ball, which completely deceived the Leslie goalkeeper. More life was infused into play after this, and while the home team did the bulk of the pressing, they were unable to take advantage of any openings which they had, through rank bad finishing. They should have been at least two goals to the good. Owing to the failing light, Mr J. Campbell, the referee, called the captains together, and after consultation, it was decided to abandon the game ten minutes from time, with each side having a goal to their credit."

Article in The Fife News: Falkland Induction Social

"In connection with the induction to Falkland East Church of Rev. Matthew Leishman, late of Kelty, a social meeting was held in the Church on Thursday evening last week. There was a crowded attendance, including large contingents from the members of Mr Leishman's former church at Kelty, and also from Freuchie. At the outset the chair was occupied by the Rev. W.J. Auld, Freuchie, interim moderator in the vacancy, who was accompanied to the platform by Rev. Mr Leishman and Miss Leishman; representatives of Dunfermline and Kinross, and Cupar Presbyteries; Rev. J.P. Batchelor, Alexandria (late of Falkland); Messrs W. Peggie and A. Anderson, representing Falkland East Kirk Session, and others.'

'After tea, the Chairman said he wished very specially to welcome all who were not members of the congregation. It was a great thing to see such a turnout. They had come together as friends to welcome the new minister, who, he was sure, would be a friend to all who wished to be friendly towards him, and a strong testimony to his friendliness could be found in the fact that there were present that night over 40 members of his former congregation. (Applause). It was nine months since the vacancy at Falkland took place, and for a time it was an anxious period, but that was now past, and a pastor had come to the congregation.'

'After an anthem by an augmented choir, and a solo by Miss Thompson, Strathmiglo, Mr A. Anderson, representing the congregation, said they wished to welcome their new minister, and a little present had been collected. On behalf of the subscribers he had pleasure in handing over a package in the shape of a wallet with Treasury notes, and hoping that Mr Leishman would have a very pleasant and profitable ministry in Falkland.'

'In reply, Mr Leishman said he had to thank them all very much. He was delighted with that audience and thought he would enjoy life in Falkland very much. They had a lovely hill, which as an Edinburgh boy he had often looked upon, little thinking that one day he would live at the foot of the East Lomond. They had got his character, and he had got theirs, and he had been told he was going to one of the best places in Scotland. He had been inducted there to preach the Gospel, and that was what he hoped to do. He hoped and prayed that their union as pastor and people would be a happy one.'

'After another anthem by the choir and a violin solo by Mr Marshall Stark, Mr Walter Peggie snr., said a very pleasant task had been laid upon him. The vacancy had lasted for nine months, and Rev. Mr Auld, as interim moderator, had had a great lot of coming and going – about twice a week or so. They had an ideal Moderator in Mr Auld, one who by his caution and kindness had kept the congregation well together. There had not been a word spoken which need cause regret to anyone. They wished to show their gratitude to Mr Auld for his services, and he called upon Miss Frances Batchelor, the young daughter of their former minister, to hand over to Mr Auld, a handsome umbrella.' 'Rev. Mr Auld, in reply, after thanking them for the present, said everybody in Falkland had been very kind and patient. He came to Falkland rather afraid how things would develop, but everything had turned out splendidly, and he expressed his gratitude specially to Mr Peggie, Mr Anderson, and all the members of Session. He did not think there could be a more harmonious Session anywhere. The members of the congregation, too, had been very kind indeed. During the nine months they had lost one member by marriage and two by death, but he was very much struck with the loyalty of all, and at the end of the vacancy, the membership was actually a little higher than at the beginning. It was not a large congregation, nor a wealthy one, but it had the quality of grit. He was sometimes said to be inseparable from his umbrella, although, indeed, he occasionally carried a walking-stick, and perhaps that might be, because he belonged to Greenock, where such things were supposed to be pretty useful. (Laughter.) At anyrate, in future, parodying the rhyme they so frequently read, he could say:

'I walk the world, a rain-tight fellow,

Beneath my Falkland East umbrella.' (Laughter.)

'A solo by Miss Sharp, Dunfermline, was followed by short appreciations of Rev. Mr Leishman by Mr Robertson, convenor of the Central Fund for the Dunfermline and Kinross Presbytery; Rev. R.W. Reid, Dunfermline; and Rev. W. Forbes, Cairneyhill. Solos by Mr A. Archibald, Falkland, and Mr Sharp, Dunfermline, preceded a hearty fraternal welcome voiced by Rev. J.K. Russell, Falkland Old Church.'

'Another violin solo having been rendered by Mr Stark, Rev. Mr Batchelor, whose removal caused the vacancy in Falkland East, said he wished to congratulate Mr Leishman. There was a fine hearty, kindly spirit in the Falkland East congregation, the members of which were loyal to one another, to their minister and their Master. He was sure he could not wish any greater happiness than he himself had in Falkland. It was 86 years since the fire was kindled in Falkland East, and ministers had come and gone, but the fire still burned, and he hoped they would extend to the new minister the loyalty they had given to his predecessors.'

'The choir rendered excellent services, while the work at the organ was taken part in by Miss C. Peggie (church organist), Miss Leishman, and Mr Walter Peggie jnr.'

'Votes of thanks having been heartily accorded, an inspiring evening closed with the benediction.'

'Mr Leishman entered upon his pulpit duties last Sunday. The forenoon service was conducted by Rev. Mr Reid, Dunfermline, who formally introduced the new minister, while the afternoon service was conducted by Mr Leishman, who outlined the principles upon which he hoped to conduct his ministry."

Ross manipulated the lantern."

Extract from The Fife News: **Whist Drive** – "For the purpose of bringing some cheer into the lives of the old folks of the town at Christmas, in the form of a treat, and gifts of tea and sugar, a whist drive was held in the Drill Hall on Friday night. The function was under the auspices of Falkland Branch of the Markinch and District Women's Guild. Thirty-one tables were engaged, and Mrs G.S. Hardie acted as timekeeper. A dance which followed was largely attended, and music was provided by the Nighthawks Orchestra from Cowdenbeath. Messrs P. Birrell and S. Drysdale acted as M.C.'s. Prize-winners at the whist were:-

30th November 1929

Article in The Fife News: Football - Falkland Thistle v Newburgh Violet

"The Markinch and District Welfare Combination fixture at Falkland on Saturday was between the above teams. The locals opened briskly, and Urquhart, their centre forward, grazed the post by inches in the first minute. The Thistle right wing gave the visiting defence a lot of trouble, and the latter's goal-keeper had to be alert. A goal always seemed to be in the making, and it was no surprise when it came. Anderson, the home right-back, drove goalwards, and the Newburgh 'keeper, while catching the ball, dropped it at the feet of the waiting Urquhart, who tipped it through. It was certainly hard luck on the goalkeeper to be beaten after such a splendid save. The visiting forwards lacked cohesion in attack, with the result that their scoring efforts were few and far between.

The homesters began the second period where they left off – attacking. P. Birrell, outside-right, changed places with Urquhart, with the object of applying more pressure in the centre. Several corners were forced, but nothing substantial accrued therefrom, due mainly to the fine goalkeeping of the Newburgh custodian. It fell to P. Birrell to register the second goal during a melee in the goal mouth. The game at this point was rather one sided, and the visiting goalkeeper was warmly applauded for splendid work. About ten minutes from time, Falkland added their third and last goal. Urquhart placed a corner kick nicely, and Munro, centre-half, sent in a splendid drive from twenty yards, which gave the goalkeeper no chance. Rain began to fall heavily, and coupled with the failing light, made conditions rather uncomfortable, and it was a relief, especially to the players, when the final whistle sounded.

"This match, under Markinch and District Welfare Combination auspices, being in the nature of a 'local Derby', attracted a goodly number of spectators. The local team was reshuffled from the previous week, with the result that several players were in unaccustomed positions. In the early period, the home defence had their 'backs to the wall', and held out grimly, despite severe pressure. Ritchie, in goal for Falkland, had several fine saves, but had to admit defeat from Young, the visiting centre forward. This reverse spurred on the home team, and 'Muchty goalkeeper had to look alert. The home forwards, while taking the ball well into the penalty area, were unable to apply the finishing touch. The interval arrived with Bellevue leading by a solitary goal.

With the wind at their backs on resuming, the homesters were expected to give a better show, and were loudly encouraged by their supporters. The visiting defence, however, took some getting past, and made no bones about their clearances. A long ball found its way to Young, and off that player went like a hare for the Thistle goal. Ritchie came out to meet him, and effected a daring save by throwing himself at the feet of the centre forward. The goalkeeper was injured and had to retire, but happily not for long. Another goal came the way of Bellevue, Young again being the marksman. Shortly afterwards the visitors were awarded a penalty, but Howie sent past. The home forwards tried hard to make headway but were met by a strong defence. It was a pity that the latter spoiled an otherwise good display by a lot of unnecessary kicking out. When the final whistle went, Bellevue were the victors by 2 goals to nil."

First Moderator-Elect of the United Presbytery

"As the oldest minister and the first Moderator-Elect of the United Presbytery of Cupar, I have been asked by the Editor to write a short message to the people within our bounds.

The Union of the Churches means that two great companies who have hitherto been marching side by side, but separate, each working on its own lines, have found that the differences between them are so slight, and the advantages of uniting their forces are so great, that they have now coalesced into one.

The Union has been brought about by the Church Courts acting in their representative capacity, but it is not the affair of ministers and elders only, and affects the whole body of the people. It rests with all of us, ministers, elders, members and adherents alike, to make the Union real and effective.

The great ends the Union has in view may be stated as on the one hand 'intensive', and on the other 'extensive'.

On the 'intensive' side we are to realise our oneness, and to join hand and heart together,

'Like brothers true to one accord,

To hold one faith and serve one Lord.'

We are now one body and our strength lies in being well compacted together, knowing each other, caring for each other, loving and helping each other.

On the 'extensive' side the purpose of the Union is to lengthen the cords and strengthen the stakes of our Church in the land. We hope to make a great united effort to gather in those who are at present outside the Christian Church.

To attain these ends, to make the Union real and effective, let us work and pray. Let us work as if the whole issue depended on our working, and pray as if all depended on our prayers. And let all the glory be given to God!"
